# LIST OF ELIGIBLE AND NOT-ELIGIBLE CANDIDATES <br> FOR THE POST OF <br> PROFESSOR IN VARIOUS DISCIPLINES 

1. The University had advertised various teaching positions at the level of Professor, Associate Professor and Assistant Professor in various disciplines vide Employment Notice No. 003/2016 dated 5th July, 2016.
2. In response to the said advertisement, the applications received for the post of Professor in various disciplines were further screened by the Screening Committee. The Screening Committee checked and verified the records of each applicant and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Employment Notice No. 003/2016 dated $5^{\text {th }}$ July, 2016; UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 and its subsequent amendments issued in year 2011/2013/2016 published in the Gazette of India.
3. Since the number of eligible applicants for the positions of Professor in each disciplines is not very large, the Screening Committee decided that all eligible applicants who meet the minimum eligibility requirements may be short-listed to be called to appear before the Selection Committee for Expert Assessment and Interview.
4. List of all applicants who have applied for the positions of Professor in various disciplines, giving general information and decision of the Committee with regard to their eligibility and non-eligibility along with the reasons thereof given below for information of concerned.

## 5. It may be noted that:

a. Decision with regard to Short-listing of applicants to be called to appear before the Selection Committee for Expert Assessment and Interview, has been made on the basis of their claim/information/certificates furnished/attached in their application forms.
b. Further, while deciding as to whether an applicant is to be called to appear for Interview before the Selection Committee, benefit of doubt has been given to the candidates, in case of any ambiguities with regard to educational qualification, experience, percentage of marks, category etc.
c. Applicants shall have to substantiate their claim through documentary proof at the time of the Interview.
d. Applicants must ensure that their details are correct and that they meet the minimum eligibility requirements, failing which they shall not be allowed to appear for Interview before the Selection Committee.
e. The eligibility of the applicants has been determined as on the last date of receipt of applications as per the Advertisement for the posts.
6. Although all efforts have been made to ensure accuracy in preparing the list mentioned at Para 4 above, possibility of inadvertent error or typographical mistake / omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any.
7. Call Letters to short-listed candidates have already been sent by POST / E-MAIL on the addresses provided by them in their applications forms.
8. In case a short-listed candidate does not receive the CALL LETTER before the Date of the Meeting of the Selection Committee, s/he must immediately contact the University at the email facultyrecruitment@mgcub.ac.in
9. The applicants who have been found Not Eligible on the basis of API score are advised that if they have any doubt, they may calculate their API on their own in the API Eligibility Calculator provided on the University Website and send the copy of their duly filled API score sheet at E-mail: facultyrecruitment@mgcub.ac.in
10. The short-listed candidates are advised to bring with them the following documents (in original) at the time of Interview to substantiate your claim that they meet the following minimum eligibility requirements for the post of Professor, failing which they will not be allowed to appear before the Selection Committee for Personal Interview:
i. Original Marks Sheets, Certificates and Degrees of all academic qualifications matriculation onward as mentioned in your application form.
ii. PhD Degree in the concerned/allied/relevant discipline
iii. A minimum of 10 (Ten) Publications as books and/or research/policy papers
iv. A Minimum of 10 (Ten) Years of teaching experience in University/College, and/or experience in research at the University/National level institutions/industries including experience of guiding candidates for research at doctoral level
v. A Minimum API Score of 400, based on Part II \& III of the UGC Regulation
vi. Duly filled up Academic Performance Indicator (API) Scoring Sheet as provided on the University Website.
11. The candidates are further advised to bring with them a set of Xerox of all the documentary proof to substantiate your claim regarding the API Score including the reprints of papers and books / monographs published by them.
12. The University will hold the Selection Committee Meetings for the post of Professor in various disciplines in two shifts i.e., MORNING SHIFT (8:30 AM onwards) and AFTERNOON SHIFT (1:30 PM onwards) as per the schedule given below:
