IMPORTANT INFORMATION TO THE APPLICANTS WHO APPLIED FOR THE POST OF **PROFESSOR** IN VARIOUS TEACHING DEPARTMENTS

1. The University had advertised the post of **Professor in various Teaching Departments** (Ref: Advt. No. 006/2019) vide **Employment Notice No. 001/2019** dated **13th May 2019**.
2. The applications received for the post of Professor in various teaching departments were screened by the Scrutiny Committee constituted by the Competent Authority.
3. The Scrutiny Committee checked and verified the records of each applicants and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Employment Notice No. 001/2019 dated 13th May 2019 and UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018.

Minimum eligibility criteria (A or B) for the post of **Professor**:

A.

- i. A minimum of **55% marks** (or an equivalent grade in a point-scale, wherever the grading system is followed) **at the Master's level**;
- ii. An eminent scholar having a **Ph.D. degree** in the concerned / allied / relevant discipline;
- iii. Published work of high quality, actively engaged in research with evidence of published work with, a **minimum of 10 research publications** in the peer-reviewed or UGC-listed journals;
- iv. A minimum of **ten years of teaching experience** in university / college as Assistant Professor / Associate Professor / Professor, and/or research experience at equivalent level at the University / National Level Institutions;
- v. Evidence of having **successfully guided doctoral candidate**; and

vi. A total **research score of 120** (One Hundred Twenty).

OR

B.

- i. A minimum of **55% marks** (or an equivalent grade in a point-scale, wherever the grading system is followed) **at the Master's level**; and
- ii. An outstanding professional, having a Ph.D. degree in the relevant / allied / applied disciplines, from any academic institutions (*not included in A above*) / industry, who has made significant contribution to the knowledge in the concerned / allied / relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

4. Department-wise list of all applicants who have applied for the post of **Professor in following teaching departments**, giving their critical information and recommendation of the Scrutiny Committee with regard to their eligibility and non-eligibility along with the reasons thereof, is attached herewith as per detail given below:

- i. **Department of Computer Science & Information Technology;**
- ii. **Department of Commerce;**
- iii. **Department of Economics;**

*(The department-wise list of applicants who have applied for the post of **Professor in rest of the teaching departments** shall be uploaded on the University Website **shortly** for information of all concerned. The concerned applicants are hereby advised to visit the University Website regularly for further updates).*

5. Although all efforts have been made to ensure accuracy in preparing the lists as mentioned at Para 4 above, possibility of inadvertent error or typographical mistake(s)/ omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants.
6. **Those candidates either declared Provisionally Eligible / Not Eligible if not in agreement with the administrative scrutiny, may submit their representation along with supporting documents latest by 5:00 PM on 4th September 2019 (Wednesday) through email only at < iqac@mgcub.ac.in > clearly mentioning their name along with name of post, name of the department, page and Sl. No. at which their names figures in the list.**

NOTE: Documents submitted in support of any such claim will be considered only if issued before the last date of submission of applications i.e., **12th July 2019**.

7. **No request for corrections and/or improvement shall be entertained after 5:00 PM on 4th September 2019.**

8. The Scrutiny Committee has screened all the applications with due care however, in case of misrepresentation of facts by the candidate found at any stage, the candidate will be disqualified.
9. Those in-service eligible candidates who have not submitted their applications through proper channel are advised to submit NOC at the time of Interview.
10. **It may be noted that:**
 - a. Since the number of eligible applicants for the aforesaid positions is not very large, therefore, the Scrutiny Committee has decided that all eligible applicants who meet the minimum eligibility requirements may be called to appear before the Selection Committee for Expert Assessment and Interview.
 - b. Recommendation with regard to short-listing of applicants to be called to appear before the Selection Committee for Expert Assessment and Interview, has been made on the basis of their claim/information/certificates furnished in their application forms.
 - c. Further, while deciding as to whether an applicant is to be called to appear for Interview before the Selection Committee, benefit of doubt has been given to the candidates.
 - d. Applicants shall have to substantiate their claim through submission of original documentary proof, prior to their interaction/interview with the Selection Committee.
 - e. Applicants must ensure that their details are correct and that they meet the minimum eligibility requirements, failing which they may not be allowed to appear for Interview before the Selection Committee.
 - f. The eligibility of the applicants has been determined as on the last date of receipt of applications as per the Advertisement for the posts.

11. **Selection Committee Meeting:**

The Selection Committee Meeting for the post of Professor in all the teaching departments as stated in Para 4 on pre-pages are likely to be held on 7th September from 9:00 AM onwards. Therefore, the candidates are advised to check the University Website regularly.
