- 1. All candidate must bring their all-academic documents and relevant valid category certificate as per GOI in original.
- 2. Admission fee of Rs.15718 /- will be submitted through **Demand Draft** only, which shall be drawn in favour of "Mahatma Gandhi Central University" payable at Motihari at the time of admission.
- 3. Candidates are advised to follow the COVID guidelines at the time of counselling.
- 4. Admission shall be strictly based on merit list, which will be prepared based on the composite score of students who have reported on their scheduled dates and time along with required documents.
- 5. All candidates are advised to check their eligibility for respective programmes as notified by MGCUB admission prospectus 2020-21 before appearing for counselling / admission.
- 6. Admission against seats falling vacant later due to one or another reasons, shall be announced later on university website.
- 7. Merely obtaining the cut off percentile or bringing Demand Draft does not guarantee admission.
- 8. Wait listed candidates shall only be considered for admission if seats remain vacant in given program of studies.
- 9. Candidates who fail to report for admission along with all the original documents on scheduled date and time shall forfeit their claim to be considered for admission.

- 10. In case of tie, the marks obtained in the merit list shall be the deciding factor and if, that is also same or result of both candidate is not declared then the senior candidate on basis of Date of Birth shall be given preference. In case of any dispute the decision of the University administration shall be final.
- 11. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 12. Admission shall be granted only on payment of fees on the specified date for each program.
- 13. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
- 14. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
- 15. In case of delay in admission/counselling process candidates have to make their own arrangement of stay.
