## OFFICE ORDER

It is hereby notified for information of all concerned that **(i)** due to resurgence of COVID-19 cases in the Country; **(ii)** keeping in mind the fact that students who are the primary stakeholders are not disadvantaged by the disruption in the teaching, learning and evaluation process and are able to complete their studies without loss of time; and **(iii)** pursuant to decision taken in the Deans' Committee Meeting held on 18<sup>th</sup> April 2021, the Competent Authority of the University has been pleased to **provisionally promote all students of the University (who have been admitted in the University during the Academic Session 2020-21 in various Undergraduate and Postgraduate Programmes of Study) from First Semester to Second Semester** without conducting their End Semester Examination at this stage.
2. However, the said End Semester Examination of the First Semester Students shall be conducted separately by the University at later stage depending upon the situation and after giving sufficient time to the students.
3. Accordingly, all Heads of various Teaching Departments are advised to prepare timetable of the classes for Second Semester in consultation with their concerned Dean and take the classes for the Second Semester through Online Mode with immediate effect till further orders.
4. All Campus Directors and Deans are requested to ensure the compliance of the orders of the Competent Authority.
