## सामान्य निर्देश

- 1. प्रवेश के इच्छुक विद्यार्थियों को सूचित किया जाता है कि वे काउंसलिंग के समय कोविड दिशा-निर्देशों का पालन करें।
- 2. प्रवेश पूरी तरह से विश्वविद्यालय की विवरणिका में किए गए प्रावधानों के अनुसार समग्र स्कोर से प्राप्त योग्यता सूची पर आधारित होगा।
- 2. प्रवेश पूरी तरह से मेरिट सूची के आधार पर होगा, जो उन छात्रों के स्कोर के आधार पर तैयार किया जाएगा जिन्होंने अपनी निर्धारित तिथियों और स्थान पर पूर्वाह्न 11:00 बजे तक आवश्यक दस्तावेजों के साथ रिपोर्ट किया है।
- 3. सभी उम्मीदवारों को सलाह दी जाती है कि परामर्श / प्रवेश के लिए उपस्थित होने से पहले एमजीसीयूबी प्रवेश विवरणिका (2021-22) द्वारा अधिसूचित संबंधित कार्यक्रमों के लिए उनकी पात्रता और अन्य विवरणों की जांच करें।
- 4. किसी न किसी कारण से बाद में रिक्त होने वाली सीटों पर प्रवेश की घोषणा विश्वविद्यालय की वेबसाइट पर बाद में की जाएगी।
- 5. केवल कट ऑफ पर्सेंटाइल प्राप्त करना या डिमांड ड्राफ्ट लाना प्रवेश की गारंटी नहीं है।
- 6. जो उम्मीदवार निर्धारित तिथि और समय पर सभी मूल दस्तावेजों के साथ प्रवेश के लिए रिपोर्ट करने में विफल रहते हैं, वे प्रवेश के लिए विचार किए जाने के अपने दावे को खो देंगे।
- 7. समान अंक होने की स्थिति में मेरिट सूची में प्राप्त अंक निर्णायक कारक होंगे और यदि, वह भी समान है या दोनों उम्मीदवारों का परिणाम घोषित नहीं किया जाता है तो जन्म तिथि के आधार पर विरष्ठ उम्मीदवार को वरीयता दी जाएगी। किसी भी विवाद की स्थिति में विश्वविद्यालय प्रशासन का निर्णय अंतिम होगा।
- 8. किसी विदेशी विश्वविद्यालय से अर्हक परीक्षा उत्तीर्ण करने वाले उम्मीदवार का प्रवेश उसकी योग्यता के विश्वविद्यालय द्वारा निर्धारित योग्यता के समकक्ष पाए जाने के अधीन होगा।
- उम्मीदवारों को प्रवेश के समय प्रवेश शुल्क के रूप में शुल्क (रु. 9218/-) का भुगतान करना होगा।
- 10. प्रत्येक कार्यक्रम के लिए निर्धारित तिथि पर शुल्क के भुगतान पर ही प्रवेश दिया जाएगा।
- 11. प्रवेश की तिथि पर भुगतान करने में विफल रहने वाले उम्मीदवारों को प्रवेश के लिए विचार नहीं किया जाएगा और मेरिट सूची में अगले उम्मीदवार को सीट दी जाएगी।

- 12. प्रवेश से संबंधित किसी भी विवाद के मामले में, मोतिहारी जिला न्यायालय का अधिकार क्षेत्र होगा।
