Re-opening of University for all First Semester Students of various PG and UG Programmes of Study, in physical mode w.e.f. 21st February 2022 (Monday) - Reg.

It is hereby notified for information of all concerned that pursuant to decision taken in the 1. 29th Meeting of Deans Committee held on 16th February 2022 regarding opening of University Campuses for students in physical mode in a phased manner, the Competent Authority has been pleased to re-open the University for all First Semester Students of various Postgradutae (PG) and Undergraduate (UG) Programmes of Study (who have been admitted in the University during the Academic Session 2021-22), in physical mode w.e.f. 21st February 2022 (Monday) while adopting requisite social distancing norms, regular sanitization and COVID-19 appropriate behavioral norms as notified by Government of India/State Government from time to time.

Further, only those students will be permitted/allowed to attend the classes physically who have been fully/partially vaccinated. Those who have not been vaccinated with even one dose will not be allowed to attend the classes physically.

- In addition to the above, it is also notified for information of all concerned that classes of rest PG and UG students (i.e., excluding First Semester Students), in physical mode shall be commenced after End-Semester Examinations which are likely to be held in the Second Week of March 2022. Accordingly, till further orders, their classes shall be held through Online Mode.
- All Campus Directors, Deans of various Schools, Heads of various Teaching Departments, 3. Dean Students Welfare, Proctor and Provost must ensure all precautionary measures to be taken to contain the spread of COVID-19.
