- 2. The admission Process is open for all students irrespective of their participation in CUET(PG)-2024, i.e. Any Candidate who could not participate in CUET(PG)-2024, may take admission after **FULFILLING ELIGIBILITY CRITERIA** applicable for admission in **M.A. ECONOMICS.** However, the candidates appeared in CUET(PG)-2024, shall be given priority in admission process.

4. Eligibility Criteria:

Bachelor's Degree from a recognized Indian or Foreign University having Economics/Commerce/Statistics/Management/Mathematics as a Subject (Honours/General) with a minimum 50% marks or equivalent grade for Unreserved (UR) Category and 45% marks or equivalent grade for SC/ST/OBC (Non-Creamy Layer)/PWD/EWS categories.

5. During Open Counselling, if the number of candidates with CUET(PG)-2024 are exhausted, merit list of candidates without CUET(PG)-2024 score card shall be prepared based on composite score to be determined on the basis of score obtained in 10th, 12th & Graduation as per following details:
