Reservation is applicable as per existing Govt. of India/MGCUB Norms.

Candidates will be required to bring the original mark sheets, certificates of all examinations, social category certificate (SC/ST/OBC/PwD/EWS latest Certificate as per GOI rules, wherever applicable. OBC Non-creamy layer certificate (Govt. of India) and EWS certificate which should have been issued on or after 01.04.2024.) issued by the competent authority and character certificate from the institution last attended. The candidates are also required to bring self-attested copies of all the documents and requisite amount of fees to be deposited through challan. Candidates possessing the minimum eligibility criteria and aspiring for admission are required to fill the following Google form by 19th July, 2024 at 10:00 AM.

On Spot Admission will be done in the following order of preferences:

- 1. Candidates who have a valid CUET (PG)-2024 (COQP08) score for M.Com, and have filled the Registration form and paid the registration fee earlier at Mahatma Gandhi Central University will be given 1st preference.
- 2. Candidates who have a valid CUET (PG)-2024 (COQP08) score for M.Com, but have not filled the registration form of Mahatma Gandhi Central University will be given 2nd preference*.
- 3. If the seats still remain vacant, the candidates who have not given the CUET (PG)-2024 exams will be given 3rd preference* and admission will be made on the basis of composite score.

The composite score will be determined as follows:-

Instructions for Candidates

- 1. Candidates are advised to report on the scheduled date and time to the venue along with required documents.
- 2. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- 3. In case of tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
- **4.** The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 5. The candidates shall be required to pay the fees in the form of **Challan** at the time of admission.
- **6.** Admission shall be granted only on the payment of fees on the specified date.
- 7. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
- 8. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
- **9.** Any addendum/corrigendum/notices to this notification shall be published only on the University Website (www.mgcub.ac.in). Therefore, Candidates are advised to check the University website regularly for any updates.
- **10.** Students are requested to come with all the documents required for admission in the course. Unable to present the required documents will lead to cancellation of the admission.
- 11. If at any stage it is found that the applicant has furnished wrong information in the Google form then the admission would be cancelled.
