## **OFFICE ORDER**

- 1. This is in continuation of ongoing admission process in various UG Programmes of Studies in the University for the Academic Session: 2024-25.
- 2. In this context, it is hereby notified for information of all concerned that the Competent Authority has been pleased to order that before going for Open/Spot admission in various Programmes of Studies, all Heads of various Teaching Departments shall ensure to exhaust the list of candidates who have registered themselves with payment of requisite amount of registration fee and could not get admission during offline (physical)/online Counselling.
- 3. Once the list of candidates as mentioned at Para 2 of above is exhausted, the concerned Head of Teaching Department shall go for Open/Spot counselling process for admission in various U.G. Programmes based on criteria circulated by Assistant Registrar (Estt. & Admin.) vide E-mail dated 05th September 2024 (Minutes of the Meeting- **Annexure I**) in this regard. Accordingly, the preference to the candidates will be given as under:
  - i. CUET Score Card holders (first preference)
  - ii. Without CUET Score Card holders
- 4. The counselling of such candidates is to be completed latest by 16<sup>th</sup> September 2024. The Heads of Teaching Departments shall also ensure to inform such candidates through e-mail as well as publish notice on the website of the University.
- 5. Further, all the Heads of concerned departments shall take necessary action to take admissions against supernumerary Self Finance/Paid Seats as defined by the Office Order no. MGCUB/Acad./SFS, dated 10<sup>th</sup> May 2024 (Annexure II); as per revised guidelines and fee structure.
