1. Admission shall be based on CUET (PG) - 2025 score.
2. All candidates are advised to check their eligibility for respective programmes as notified by the NTA Information Bulletin for admission in the PG programme through CUET (PG) – 2025.
3. In case of tie, senior candidate based on Date of Birth shall be given preference. The University administration's decision shall be final in case of any dispute.
4. The admission of candidate who has passed their qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
5. Admission shall be granted only on the payment of fees on the specified date.
6. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
7. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
8. Any addendum/corrigendum/notices to this notification shall be published only on the University Website (www.mgcub.ac.in). Therefore, Candidates are advised to check the University website regularly for any updates.
