1. The University had advertised the post of **Professor in various Teaching Departments** as per details given below:

2. The applications received for the post of Professor in various teaching departments were screened by the Screening Committee constituted by the Competent Authority.
3. After going through all the relevant documents (*viz. application form and supporting documents as submitted by the candidate*), the Screening Committee checked and verified the records of each applicant and determine their eligibility strictly in accordance with the minimum qualification prescribed by the University and included in the said advertisement, and as per the norms prescribed by the University Grants Commission, New Delhi in “UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018”, and as amended from time to time and further necessary orders/circulars/directions issued by the University Grants Commission/ Ministry of Education in this regard.
4. Department-wise list of all applicants who have applied for the post of **Professor in following teaching departments**, giving their relevant information and recommendation/decision of the Screening Committee with regard to their eligibility and non-eligibility status (*viz. provisionally eligible/eligible or not eligible*) along with the reasons thereof, is placed below as per detail given below:

The concerned applicants are hereby advised to visit the University Website regularly for further updates).
5. Although all efforts have been made to ensure accuracy in preparing the lists as mentioned at Para 4 above, possibility of inadvertent error or typographical mistake(s)/omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants.
6. **Those candidates (either declared Provisionally Eligible / Not Eligible), if not in agreement with the recommendation/decision of the Screening Committee, may submit their representation along with self-attested supporting documents latest by 5:00 PM on 27<sup>th</sup> September 2025 (Saturday) through email only at < [rac@mgcub.ac.in](mailto:rac@mgcub.ac.in) > clearly mentioning their name along with candidate ID, name of post, name of the department, page and Sl. No. at which their names figures in the list.**

**NOTE:** Documents submitted in support of any such claim will be considered only if issued **before the last date prescribed for submission of filled-in applications through Online Mode – CU Chayan Portal was 10<sup>th</sup> January 2025 (Friday).**

**Thereafter, the University will take a final decision regarding their eligibility, including whether they should be invited to appear before the Selection Committee for Expert Assessment and Interaction.**

7. **No request for corrections and/or improvement shall be entertained after 5:00 PM on 27<sup>th</sup> September 2025 (Saturday).**
8. The Screening Committee has screened all the applications with due care however, in case of misrepresentation of facts by the candidate found at any stage, the candidate will be disqualified.
9. Those in-service eligible candidates who have not submitted their applications through proper channel are advised to submit No Objection Certificate (NOC) from their present employer at the time of Interview.
10. **It may be noted that:**
  - a. While calculating the research score of a teacher, the combined score obtained under Category 5(b): Policy Documents and Category 6: Invited Lectures/ Resource Person/Paper Presentations, shall be subject to a maximum limit of 30% of the total research score of the teacher concerned. This cap has been applied on 30% of total research score acquired in Categories 1, 2, 3, 4, 5(a) and 5(c), or the actual combined score of Categories 5(b) and 6, whichever is lower.
  - b. Since the number of eligible applicants for the aforesaid positions is not very large, therefore, the Screening Committee has decided that all eligible/provisionally eligible applicants who meet the minimum eligibility requirements may be called to appear before the Selection Committee for Expert Assessment and Interaction/Interview.

**Important Note: In respect of the position(s) [belonging to Unreserved (UR) or Other Backward Class (OBC) category] where the number of eligible candidates to be shortlisted for interview is less than three, the post(s) shall be re-advertised by the University.**
  - c. Recommendation of the Screening Committee with regard to short-listing of applicants to be called to appear before the Selection Committee for Expert Assessment and Interaction/Interview, has been made solely on the claims/information/certificates submitted by the applicants along with their application forms.
  - d. Further, while deciding as to whether an applicant is to be called to appear before the Selection Committee for Expert Assessment and Interaction/Interview, benefit of doubt has been given to the candidates.

- e. Applicants shall have to substantiate their claim through submission of original documentary proof, prior to their interaction/interview with the Selection Committee.

Applicants must ensure the accuracy and authenticity of all documents/enclosures submitted. Further, applicants must also ensure that their details are correct and that they meet the minimum eligibility requirements. In the event of any discrepancy or failure to meet the minimum eligibility criteria, the candidate may be disqualified from appearing before the Selection Committee for Expert Assessment and Interaction/Interview.

- f. Following final selection and appointment, the University will verify all relevant documents (*submitted by the selected candidates along with their Application Form*) related to the minimum eligibility criteria for the respective post from the concerned university/department/institution/organization
- g. The eligibility of the applicants has been determined as on the last date for the submission of filled-in applications through Online Mode – CU Chayan Portal, i.e., **Friday, 10<sup>th</sup> January 2025.**

11. **Selection Committee Meeting:**

**The Selection Committee Meeting for the post of Professor in the teaching departments as stated at Para 4 on pre-pages are likely to be held shortly. Therefore, the candidates are advised to check the University Website regularly.**
