
Candidates seeking admission to the Ph.D. programme of the Department of Biotechnology are required to attend the offline Interview. Candidates are required to report as per the following details:




### Important Notice:

2. Candidates are required to report personally on the scheduled date and time to the venue along with required documents.
3. Candidates are required to come with a Research Proposal to be presented before the Department Research Committee (DRC) during the interview.
