Students are requested to visit the University website regularly. Reservation is applicable as per existing rules and norms applicable at MGCU.**

**Note:**

1. Provisional admission shall be strictly based on the merit list derived from the composite score of marks of relevant examination and marks of interview in accordance with the provisions of the University Ordinance.
2. Candidates are required to report personally on the scheduled date and time to the venue along with required documents.
3. Candidates are required to come with Research Proposal (5 hard copy) and PPT (Max 10 slides of ppt) to be presented before the Department Research Committee (DRC) during the interview.
4. All candidates are advised to check their eligibility for respective programmes as notified by MGCU admission prospectus 2025-26

The decision will be taken on the basis of suitability of the candidate vis-à-vis readiness of supervisor in proposed research area as well as availability of resources.**
6. Candidates who fail to report personally for provisional admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for provisional admission.
7. Candidates who fail to make the payment by due date shall not be considered for provisional admission and the seat will be given to the next candidate in the merit list/waiting list (if any).
8. In case of any dispute related to the provisional admission, the High Court of Patna shall have the jurisdiction.
9. Any addendum/corrigendum/notices to this notification shall be published only on the University website ([www.mgcub.ac.in](http://www.mgcub.ac.in)). Therefore, candidates are advised to check the University website regularly for any updates.
11. No TA/DA will be paid to the candidates for appearing in Interview for admission to the above programme.
12. Students are requested to come with all the documents required for admission in the course. Unable to present the required documents will lead to cancellation of the admission.
13. The scheduled Interview for provisional admission is likely to be continued till late evening or next- day depending upon the circumstances. Therefore, the candidates are advised to make their own arrangement for stay etc. accordingly.
14. Provisional admission shall be granted only on the payment of fees by due date.
15. **The candidates shall be required to Deposit the Fees through Samarth Portal (online) From 19/02/2026(Thursday) to 21/02/2026 (Saturday).**

8. Bank Account detail of student i.e. Account No., IFSC-Code, and Name of account holder & address of Bank.
9. A Character Certificate from the Head of the Institution last attended.
10. Transfer/Migration Certificate (in original) from the Head of the Institution /University last attended.
11. Affidavit for intervening period/gap of over three years, if applicable on 100/- stamp paper.
12. SC/ST/OBC(NCL)-latest/PwD/EWS-latest Certificate as per GoI rules, wherever applicable.
13. No Objection Certificate (NOC) from Employers, wherever applicable.
