Instructions for candidates

1. Formats of selected documents required are specified in the e-Prospectus for Academic Session 2025-26.
2. Admission shall be strictly based on **merit list** derived from the **composite score** taken together on the basis of giving 70% weightage to the Valid NET Score and 30% weightage to the Interview / viva-voce.
3. **Admission fee** for the PhD programme is **Rs. 24,750/-** . Admission fee would be deposited on the day of admission after document verification through Samarth portal. Fee structure and other details are provided in the e-Prospectus for Academic Session 2025-26.
4. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be cancelled.
5. **Admission** into PhD programme **would be confirmed only after** document verification and submission of proof of fee deposit through Samarth portal.

Admission of candidates seeking admission after a gap of three or more academic years of their taking certificate/ diploma/degree/postgraduate degree from this University or any other University/educational institution/Board, shall be subject to the clearance by the **Admission Review Committee** consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the Head of the Department concerned and the Proctor.
