With reference to the Admission Notification (5 Years Integrated UG-PG Programme), Academic Session 2026-27 dated 6 July, 2026 ([https://mgcub.ac.in/storage/content\\_files/1783343374\\_cuet%20ug%202026.pdf](https://mgcub.ac.in/storage/content_files/1783343374_cuet%20ug%202026.pdf)), for the vacant seats and Self-Finance seats, **Merit List of 100 eligible candidates (for Self-Finance Seats), and Merit list of 50 eligible candidates (for regular SC seat)** have been prepared on the basis of the prescribed merit criteria. Admission against the available seats shall be offered **strictly in order of merit**, subject to fulfilment of the prescribed eligibility criteria and applicable reservation norms.

2. The Merit Score is calculated as the sum of the marks obtained in **Mathematics, Physics,** and the highest score among **Chemistry, Biology, Computer Science, and Informatics Practices** in the CUET Examination.

The details of vacant seats, as of now, are given below (subject to variation, if other admissions are cancelled/withdrawn):

3. From the pool of candidates (listed below) who **report within due time on the day of counselling**, admission would be done in order of merit for all the categories on vacant seats, subject to reservation rules and overall intake capacity.
4. The regular seats (**01 vacant SC seat**) shall be filled from the eligible candidates belonging to the respective categories, in accordance with the applicable reservation norms and **strictly on the basis of merit**. The Merit list for regular SC seat is attached bellow.
5. **The Self-Finance (Paid) Seats** shall be filled from the merit list **irrespective of category**, subject to fulfilment of the prescribed eligibility criteria.
6. Candidate admitted under the **Self- Finance Scheme (Paid Seats)** shall not be allowed to switch to regular seats under any circumstances.
7. **Fee** payable at the time of admission into the B.Tech./MTech (5 Years Integrated programme) is **Rs. 25,218/- for regular seats** and **Rs. 65,218/- for self-finance seats**. The **fee would be deposited on the day of admission** after document verification on Samarth portal.
8. In case a candidate does not complete the admission formalities or fails to deposit the prescribed fee within the stipulated time, his/her candidature for the concerned round of admission shall be treated as **cancelled**, and the vacant seat may be offered to the next eligible candidate in the Merit List.
9. Before proceeding with counselling or admission, candidates must ensure they meet the eligibility criteria in the relevant notifications.
