1. **2nd Open Counselling-Cum-Admission** process for vacant seats in M.Sc. in Botany Programme of Mahatma Gandhi Central University, is scheduled to be held on- **21st August 2026** for both CUET(PG)-2026 Candidates and Non CUET (PG) 2026 candidates (who do not possess a CUET (PG) 2026 scorecard. The last date to apply for admission through the Open Counselling-cum-Admission Process is **20th August 2026** (Till 5:00 PM).

2. The following candidates may register to appear in the open counselling:
 1. The Candidates who have a valid CUET (PG) – 2026 score card;
 2. The Candidates not having the CUET (PG) – 2026 score card but fulfilling the eligibility criteria of MGCUB.

However, the candidates who appeared in CUET(PG)- 2026 shall be given priority in the admission process.

4. Eligibility Criteria:

Bachelor's degree in Botany/Plant/Life/Biological or Agriculture sciences with Botany as one of the major subjects for at least one year or two semesters from a recognized Indian or foreign University (foreign recognition to be as per AIU list) with a minimum 50% marks or equivalent grade for Unreserved category and 45% marks or equivalent grade for SC/ST/OC (Non-Creamy Layer)/PWD/EWS candidates.

7. Fee of Registration:

A merit list shall be prepared according to the University's admission policy on the same day, and an offer of admission shall be provided to selected candidates as per merit.

4. **In case of a tie, the senior candidate, based on Date of Birth, shall be given preference.** In case of any dispute, the University administration's decision shall be final.
5. The admission of a candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
6. The candidates shall be required to pay the fees through **Samarth portal** at the time of admission.
