6. **The candidates shall be required to pay the fees online at the time of admission.**
7. Admission shall be granted only on the payment of fees on the specified date.
8. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
9. In case of any dispute related to the provisional admission, the High Court of Patna shall have jurisdiction.
