Instructions for candidates

1. From the pool of candidates who **report within due time on the day of counseling**, admission would be done in order of merit for all the categories on vacant seats, subject to reservation rules and overall intake capacity of **33 seats and 11 Supernumerary/Paid Seats** in BAJMC.
2. **Fee** payable at the time of admission into the **B.A. – M.A. (5 Years Integrated UG-PG in Journalism and Mass Communication) Programme** is **Rs. 9,218/-** and the fee would be deposited on the day of admission after document verification on Samarth portal. Fee structure and other details are provided in the **Admission notification (Under Graduate Programmes), Academic Session: 2026-2027** available at the link: (https://drive.google.com/file/d/1_wLE8SiXpMFCYccWDtLsgvcV_5jr8Yu5/view?usp=drive_link).
3. The students, to be admitted under the Self-Finance Scheme, shall have to deposit/pay Rs.10,000/- per semester in addition to regular fees paid by the students admitted under the Non-Self-Financed category.
4. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be cancelled.
5. **Admission** into **B.A. – M.A. (5 Years Integrated UG-PG in Journalism and Mass Communication) Programme** would be confirmed only after document verification and submission of proof of fee deposit.

Admission of candidates seeking admission after a gap of three or more academic years of passing Intermediate/10+2 examination from any University/educational institution/Board, shall be subject to the clearance by the **Admission Review Committee** consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the Head of the Department concerned and the Proctor.
