The selected candidates need to pay admission fees online on the same day by 2:00 PM failing which the seat will be allotted to the next candidate as per the merit. To participate in the open counselling, candidates have to register on the link (<https://mgcubadm.samarth.edu.in/>) on or before 18th August, 2026 for the open counselling by paying the registration fee (Rs. 500/- for Gen/OBC/EWS and Rs. 200/- for SC/ST/PWD). The admission against the vacant seats will be made as per the criteria given in notification for earlier Open Counselling in July 2026.
