1. All the registered students are required to report for Document Verification as per following details:
 - **Date: 27th August 2026**
 - **Time: 10:00 AM – 01:00 PM**
 - **Venue: Department of Economics, Gandhi Bhawan Campus, Bankat, Mahatma Gandhi Central University, Motihari, Bihar – 845401**
2. The registered students are required to bring the following documents in original as well as a set of attested photocopies at the time of reporting:
 - CUET (UG) – 2026 Application Form and Scorecard, wherever applicable.
 - Mark sheets and certificates of 10th and 12th.
 - Five copies of recent passport-size photographs.
 - Self-attested copy of AADHAR card.
 - Bank Account details of the student, i.e. Account No., IFSC-Code, Name of account holder & address of Bank.
 - A Character certificate from the Head of the Institution last attended.
 - Transfer/Migration Certificate (in original) from the Head of the Institution last attended.
 - Affidavit for intervening period/gap of over three years, if applicable on 10/- stamp paper.
 - SC/ST/OBC/PwD/EWS Certificate as per GOI rules, wherever applicable.
 - No Objection Certificate (NOC) from Employers, wherever applicable.
 - Anti-ragging forms duly signed by the students & parents/guardians.

3. Important Instructions

- Candidates are required to report on the scheduled date and time to the venue along with the original documents.
- Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
- The admitted candidates shall be required to pay the required fees. Admission shall be granted only on the payment of fees.
- **Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the waiting list.**
