- 3. In case of tie, senior candidate based on Date of Birth shall be given preference. The University administration's decision shall be final in case of any dispute.
- 4. The admission of candidate who has passed their qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 5. Admission shall be granted only on the payment of fees on the specified date.
